



**ALBATROSS PARTICIPATION & CONDUCT
(OVERSEAS TOURNAMENTS) RULES 2012.**

1. The Albatross Participation and Conduct (Overseas Tournament) Rules comes into effect June 15, 2012 and shall govern the conduct of the Players & accompanying Parents for the visit and participation of the Junior Players of Albatross Junior Tour, India, (for short referred to as AJT) shortlisted/selected/invited for any specified event outside India.
2. Albatross Junior Tour (AJT) aims to facilitate Junior Players for participation under the banner of ALBATROSS JUNIOR TOUR (INDIA) to any designated Overseas International Tournament. The participation of its Junior Players shall be as a player from ALBATROSS JUNIOR TOUR - INDIA.
3. Player(s) selected for participation in any International Tournament –overseas either on the basis of the All India Albatross Order of Merit for the relevant year and/or on the basis of a designated qualifier or invitation in discretion of AJT, shall be governed by these rules.
4. Players shall be bound by the following conditions:
 - i. The Player's entry shall be subject to Player submitting the prescribed entry form, duly filled and signed by Player & Parent.
 - ii. The Player submits a copy of Passport along with the Entry form. All to ensure that the Passports of all travelling are **valid for next 6 months**.
 - iii. Parent/family is encouraged to accompany the team; they must cooperate and support the manager's decision(s) in true spirit. It is optional for Players 15 & above. Player must indicate name and relations of accompanying Parent, if any. However no Player less than 15 years of age shall have a right to visit /travel /participate in overseas tournament without an accompanying Parent regardless of his selection and/or rank in Order of Merit.
 - iv. The Parents of unaccompanied Players shall also deposit with the Manger a rough estimated amount in cash of \$250 (for Asian Countries) and \$ 400 (for US/Europeon countries) towards out of pocket expenses, i.e., meals , and/or other incidental expenses during the visit and tournament. Any shortfall shall be reimbursed later by the Parent. Of course an unused amount, if any, would be accounted for and refunded.
 - v. It is strictly desirable that all Junior Players & Parents adhere to the Albatross itinerary. All players shall travel together on same flight /itinerary. A player if accompanied by Parent may with prior intimation/permission deviate but only from the return team itinerary.
 - vi. The Players shall compulsorily attend Orientation & Team Meetings on a day /time nominated by Manager.
 - vii. All Players shall attend Opening and Closing ceremony compulsorily and wear Albatross attire as recommended by the Manager. Non participation shall be taken as misconduct and outrageous violation of the Albatross Rules and etiquettes.
 - viii. Non participation in the Opening ceremony shall disentitle Player from participation in the tournament and /or such other penalty as AJT Board may decide. Non- participation in Closing ceremony shall entail Player

- to such penalty (to the extent of debarring the Player from all future Albatross Tournament domestic or overseas for such terms as it may decide) as AJT Board may decided .
- ix. All Players shall strictly maintain discipline, adhere to the Tournament conditions of play, and also maintain etiquettes, discipline, dignity, integrity in line with our Indian culture and traditions more so in view of the fact that while you are visiting a foreign land and any good and bad action on your part may be taken as done by an Indian generally and thus enhance /effect all of us as Indians and country as a whole.
 - x. The accompanying Parent(s) is/are expected to appreciate and ensure adherence to these rules.
 - xi. The Contravention, non adherence of any of the above rules, directive shall be deemed to be indiscipline and misconduct shall be dealt with by the Manager while the tour is on. Manager shall be entitled to disqualify the Player from participating and/or disqualified from being a Team member while on tour and all consequences as a result thereof shall follow. The decision of Manager accompanying the team shall be final and binding on all.
 - xii. All Parents shall bear their own cost/expenses.
 - xiii. Visa, International Medical Insurance shall be mandatory for all and the cost shall be borne by the Players/Parents
 - xiv. The Tournament Conditions of Overseas Competition shall govern and bind all Players.
 - xv. All juniors shall pay a non-refundable and non-adjustable sum of Rs 5000/- as processing expense. The payment shall be made online at www.albatross.co.in .Go to Shoppe on Left side Menu and click on the specific tournament and proceed as directed by using credit /Debit card. The exemptions shall be applicable as specifically prescribed for a designated tournament or Player.
 - xvi. The Payment towards Entry/Registration Fee, Accommodation and all related and incidental expenses including visa fee , insurance , excess baggage , F&B shall be borne/paid by Player/Parents on behalf of Player, unless specifically exempted by AJT.
 - xvii. The Entry Form along with other documents shall be submitted either by sending scanned copy by E – mail at rajiv@albatross.co.in or by Fax at 41630524 or by courier at ALBATROSS C/O Rajiv Talwar E-257 Greater Kailash -1 New Delhi 110048 on or before the last date of submission.
 - xviii. Official Travel agent is M/s Uday Tours & Travel, New Delhi. All Travel arrangements shall be with our authorized Travel Agent with contact details as below:

4. The Juniors Players selection shall be on basis of the Conditions of the designated Qualifier or the Rules as to All India Albatross Order of Merit Rules as applicable.
 5. The AJT shall appoint and nominate a Manager for each overseas contingent .The appointment of Manager to the Tour shall be at the sole discretion of the ALBATROSS BOARD only. The Manager shall hold all powers of general management and control of the Players. All Players shall be bound by
 7. The Information and Conditions of Competition shall be set down by the Host Organizers and shall be circulated and be binding on all Players. All the conditions mentioned shall govern all the Players and Relations/Persons accompanying the Player.
 8. AJT shall be within its rights to clarify these rules and /or alter, modify and/or amend these rules.
